

## **Authorisation to Capture and Broadcast Your Child's Image**

This is the read-only English version of our Autorisation de Captation et de Diffusion de l'Image. The French version needs to be signed within the application pack.

The law requires schools to request permission whenever they, through their teachers, wish to photograph and/or film pupils in the context of school and extra-curricular activities.

If you prefer not to fill in this form, no photos of your child will be taken and your child will not appear on any medium (paper, digital, magnetic, fabric, plastic, etc.).

Description of the educational project for which this authorisation is required (objective, date, teacher, and accompanying persons): Activities in class and within the school involving all staff of Rainbow School Paris and Rainbow PreSchool.
